THE TWELVE TRADITIONS

- 1. Our common welfare should come first; personal recovery depends upon AA unity.
- 2. For our group purpose there is but one ultimate authority-a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do
- 3. The only requirement for AA membership is a desire to stop drinking.
- 4. Each group should be autonomous except in matters affecting other groups or AA as a
- 5. Each group has but one primary purpose to carry its message to the alcoholic who still suffers.
- 6. An AA group ought never endorse, finance or lend the AA name to any related facility or outside enterprise, less problems of money, property and prestige divert us from our primary purpose.
- Every AA group ought to be fully self-supporting, declining outside contributions.
- 8. Alcoholics Anonymous should remain forever nonprofessional, but our service centers may employ special workers.
- 9. AA, as such, ought never be organized; but we may create service boards or committees directly responsible to those they serve.
- 10. Alcoholics Anonymous has no opinion on outside issues; hence the AA name ought never be drawn into public controversy.
- 11. Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio and films.
- 12. Anonymity is the spiritual foundation of all our Traditions, ever reminding us to place principles before personalities.

THE TWELVE STEPS

- 1. We admitted we were powerless over alcohol---that our lives had become unmanageable.
- Came to believe that a power greater than ourselves could restore us to sanity.

 Made a decision to turn our will and our lives over to the care of God as we understood
- 4. Made a searching and fearless moral inventory of ourselves.
- 5. Admitted to God, to ourselves, and to another human being the exact nature of our wrongs.
- 6. Were entirely ready to have God remove all these defects of character.
- 7. Humbly asked him to remove our shortcomings.
- 8. Made a list of all persons we had harmed, and became willing to make amends to them
- 9. Made direct amends to such people wherever possible, except when to do so would
- Continued to take personal inventory and when we were wrong, promptly admitted it.
 Sought through prayer and meditation to improve our conscious contact with God as
- we understood him, praying only for knowledge of his will for us and the power to carry
- 12 Having had a spiritual awakening as the result of these steps, we tried to carry this message to alcoholics, and to practice these principles in all our affairs.
