TREASURER'S REPORT: Jim C: Passed the basket - \$102 was collected

- 1. Jim distributed the P&L Feb 2019 actuals for 2018 vs 2019. It shows YTD Feb 18 vs Feb 19 and Jan-Feb19. Net income of \$2351 in Feb19 vs \$801 in Feb18; this is due to reductions in our outside fees
- 2. For the first time also, a cash balance sheet was distributed, for Feb19, showing Intergroup's assets vs liabilities. The numbers show that Intergroup is getting healthier.
 - A. Although we do not currently have a formal prudent reserve set up, the Board has discussed setting aside current savings into a prudent reserve. Next steps are to identify how much we need to set aside.
- 3. Group contributions are listed on the back of the Balance sheet, and are shown as year to date (YTD).
 - A. Accounts Receivable *1 is a special account that is treated like a group. When we take money out of our savings to fund it, it will show up as negative number as we owe that much in merchandise, cook-off etc.
