TREASURER'S REPORT: Jim C.

- 1. <u>The P&L Comparison</u> was sent out and contains 2019 and 2020 performance. Total income was \$20,817 and COGS was \$9,082. Gross Profit was \$11,734. If we remove all expenses (\$11,085) and this leaves a net ordinary income of 649.61. When we compare to a year ago it is slightly down but in relation to last month is an improvement. We are encouraged by the fact that contributions have increased by \$2,100 and merchandise sales have also increased over last couple of months, as the meeting schedule is more regular for groups.
- <u>2. The Reps Balance Sheet</u> We have cash on hand in the savings account in the amount of \$47,348.22 and the checking account is approaching \$25,000. Normally we would decide in September-November if we want to move funds to prudent reserve. Current total in the prudent reserve is \$54,147. We have not needed to draw on this because we are semi-healthy from a cash point of view. We have our groups to thank for that.
- 3. Group Contributions for the Year This is a 2-page report If a group has been contributing and amount is not right or something is missing, reach out to Jim C. or Dave H. and we will get it corrected. Looking much healthier compared to the past 3 to 6 past months.
