## Chair: Tom

Tonight, we will be doing elections. There are 5 open positions for Board members. Four are for a 2-year commitment and 1 is for 1-year term which was unfilled during this last term due to one of the Board members dropping off.

Candidates will give an introduction of themselves, their sobriety date, what group they attend and their service resume.

Then we will go to vote using the Zoom polling feature. We are going to walk you through.

5 open slots – we will vote for each individually. The person voted in will drop off the next poll, we do another vote and so on.

Russell – Preston – June 7, 2002

Got sober in Houston. Was a GSR for a term, was on the Houston Round Up Board for 3 years. He brought meetings to the psychiatric ward for 5 years, and was on the Gathering of the Eagles committee for 3 years.

Gordon – Chicago Group – Sept 21, 2015

He has held commitments at meetings. Attends 3-5 conferences a year and takes on commitments. Was the Intergroup Rep, currently serving as PI/CPC chair for the area. Believes service work is important to sobriety.

Lisa – Preston – Dec 18, 1997

Served as a lead for the jail team for 15 years, was on the committee for Crested Butte for 15 years, and served on the 24 Club Board.

Anthony – Chicago – Nov 12, 2007

Active in his home group, served in various capacities. Last year was the Intergroup Rep, served as Treasurer, Asst Secretary and Secretary.

Mike – Clean Air North – 24 years sober

Chairs meetings, was Treasurer at Preston, and took meetings to Green Oaks.

Terry – Addison Group – Sept 11, 2012

Served on Gathering of the Eagles for 3 years, Intergroup Rep, Secretary, was on the Board of Singles in Sobriety for 2 years and Maggie's for 7 years.

Lindsay – Preston Group – Aug 19, 2015

Served at Homeward Bound and Phoenix rep for PPG. She's an active driver for Maggie's house, serves on Nightwatch, was an Alternate Intergroup rep and is current Intergroup rep. Want to serve in the 1-year open position, and is willing to serve the 2-year term. Likes Nightwatch.

Four rounds of elections for the 2-year terms and the 5<sup>th</sup> person we elect will sit for the 1-year term. The Standing committees for the Board will be decided during the next Board meeting.

You will vote only if you are an Intergroup Rep, or if you are the Alternate standing in, you will vote. Otherwise, you will not be voting.

There are 33 Total Votes.

The Zoom polling screen will pop-up a list of candidates. Each round vote your top for choice, then there will be a second round and a third and so on.

Gordon – 33 votes – 63% (We now have 2 Board members from Chicago)

Lindsay – 31 votes – 43% (We now have 2 Board members from Preston)

Terry – 56% - selected for 2-year term

Mike – 43% - selected for the 1-year term

Anthony – 56% - 1st Alternate

Russell – 43% - 2nd Alternate

Newly elected Board members need to attend the December Board Meeting second Thurs of the month (Dec 9 @ 7:00). Afterward is the Intergroup Rep Meeting @ 8:00.
